



Password Protected Private Data Dashboard

Districts may purchase a two-year subscription to a password protected, private [data dashboard](#) that displays up to nine years of CHKS, CSSS, and CSPA data at the district and individual school level at the California Department of Education subsidized rate of \$75 per eligible school.

The dashboard provides designated staff with graphical data displays from:

- ◆ the district as a whole;
- ◆ all schools in the district on the same page to compare results across schools; or
- ◆ a single, individual school.

At both the district and school level, viewers can:

- ◆ compare their data with district and state averages;
- ◆ make comparisons across subgroups such as race/ethnicity, sexual orientation, gender identity, and afterschool participation; and
- ◆ examine data trends over time overall and by subgroup.

Viewers at both the district level and the school level have the option to download data displays as a PDF document which can be shared with stakeholders. The system allows district coordinators to set up differential access for different staff. For example, access to data from a specific school can be provided solely to specific staff who are working at that school.

FAQs

Can a district purchase a subscription for only a few school sites?

- ◆ No. The Private Data Dashboard is offered for the district and includes all eligible school sites. The fee of \$75 per eligible school (those schools serving grades 5, 7, 9, 11 and NT) is the formula for the subsidized rate for districts. Whether you provide individual school access to one school, all schools or no schools, the formula remains the same.

We give the survey every year, do we have to purchase a subscription every year?

- ◆ No! It is a two-year subscription and data will be updated every year.

Do I have to administer the survey this year to purchase a subscription?

- ◆ No! You can get access to results from past survey administrations immediately.

We have an external evaluator who needs access to the individual school level data, will they be able to access the individual password protected accounts for grant analysis purposes (ex. TUPE)?

- ◆ When you register and pay for the two-year subscription, you will provide official district email addresses for the designated viewers. If you provide your external evaluator with district level access, they will be able to see district and school level data.

In the past we have purchased school level reports. Will that same format be readily available through the Private Data Dashboard so a site could simply print that format without having to reconstruct it?

- ◆ No. If a school site wants a PDF of the school level report in the same format as the PDF of the district level report, that must be ordered and purchased separately for \$75 per school report. This is a cost per school that orders the report, not an assessed fee subsidized by the CDE. If you only order a PDF for one school, the cost will only be \$75. If you order reports for two schools it will be \$150, etc.

Will the Private Data Dashboard have all the same data that the PDF report will have?

- ◆ Eventually, yes. Right now, key indicators listed in Table A.2.1 and Table A.2.2 of the PDF report, along with a few additional items are included on the dashboard; however, the data dashboard offers options the PDF report does not. All data on the dashboard can be disaggregated by multiple subgroups beyond race/ethnicity and gender. The dashboard displays data trends for up to six years of data and the dashboard displays data trends disaggregated by one or two subgroups.

Will the staff and parent data be included on the Private Data Dashboard?

- ◆ Yes.

Can a school site with the data dashboard access see the district level data within their subscription?

- ◆ Yes, all school level data includes a district data comparison and (if available) a state data comparison.

I'm a county coordinator, can I pay for access to all districts in my county so that I can see district by district comparisons on the same page?

- ◆ No, the current dashboard does not allow for countywide subscriptions and district comparisons; however, if a district chooses to do so, they may include the county coordinator's email as part of the district's subscription to the private dashboard.
